A World Without Abuse -- Expanding the Circle is a community arts exhibition with roots in social justice. Its purpose is to engage community members in recognizing the interrelated structure of our society, specifically regarding child abuse. All members of society contribute to the systems, social norms, and individual behaviors that, held together, shape our world. Creating a safe community for everyone – including all children, tweens, and teens – starts with a shared vision of a world without abuse. By helping to co-create this vision, everyone can actively expand our region's circle of protection.

The Challenge

Create an original art work that depicts your vision of a world without abuse, incorporating a circle or circles into the design. All art media are welcome and all members of the community – seasoned artists, novices, or just plain folks – are invited to participate.

The Exhibit

The exhibit will begin in April 2018 as part of National Child Abuse Prevention Month and in recognition of National Crime Victims Awareness Week. Artwork will be displayed in various venues throughout the Grand Traverse Region depending on availability and number of entries. A celebration of the exhibit is scheduled for **Sunday, April 29, 2018** at the Dennon Museum Center in Traverse City, Michigan.

ARTWORK RELEASE FORM

The undersigned _____, being the legal owner of, or having the right to certain art work, or series of art works to be used by the Traverse Bay Children’s Advocacy Center (“TBCAC”), does grant to TBCAC and its legal representatives, agents and assigns, the full right to display said art work(s), incorporate images of said art work(s) into greeting cards and promotional materials for TBCAC, and gift said art work(s) to donors of TBCAC.

The undersigned also consents to the use of the images of said artwork in any printed matter and advertising and marketing materials used to promote TBCAC.

The undersigned owner hereby waives any right that he/she may have to inspect or approve the finished greeting cards, or the advertising copy or printed matter that may be used in connection therewith, or the use to which it may be applied. TBCAC hereby agrees that any proceeds derived from the sale, publication, or use of the art work(s) shall become the property of TBCAC and used exclusively for the advancement of TBCAC in furtherance of its mission.

The undersigned owner hereby waives any right that he/she may have to inspect or approve the advertising copy or printed matter that may be used in connection with the display of the art work(s), or the use to which it may be applied. TBCAC hereby agrees that any proceeds derived from the display or use of the art work(s) shall become the property of TBCAC and used exclusively for the advancement of TBCAC and its mission.

The undersigned hereby releases, discharges, and agrees to hold harmless TBCAC, its legal representatives, and assigns, and all persons acting under its permission or authority, or those for whom it is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur in the production of promotional materials or in any subsequent processing thereof. The undersigned owner hereby warrants that he/she is of full age and has every right to contract in his/her name in the above regard or is the properly appointed legal guardian of the person and property of the owner hereof.

The undersigned states further that he/she has read the above authorization, release and agreement, prior to its execution, and that he/she is fully familiar with the contents thereof. If the undersigned is signing as a legal guardian, the undersigned warrants that he/she is fully authorized to do so.
